## History of Greene County Memorial Hospital Foundation

Greene County Memorial Hospital Foundation (GCM-HF) was formed as the result of the sale of Greene County Memorial Hospital in October, 2005 to Essent Healthcare, a for-profit organization based in Nashville TN. The hospital traces its roots to the years 1904 and 1905 when two Waynesburg physicians, Dr. Harry C. Scott and Dr. Frank Ullom, opened the first hospital in Greene County.

By 1907 the hospital earned accreditation by the Joint Commission on Accreditation of Hospitals and the Department of Public Welfare in recognition of its programs and professionalism. Twenty years later Waynesburg Hospital officially changed its name to Greene County Memorial Hospital and began operating as a non-profit corporation.

GCMH continued to grow in response to the needs of the community and with the support of the Auxiliary, built a completely modern three-story facility. The 88-bed hospital officially opened in February, 1938. Over the decades to come, the hospital built many additions to the original structure, concluding with a five-story addition which was completed in 1976.

Today the original hospital, now known as Washington Health System Greene, and GCMHF are doing their part to advance healthcare initiatives throughout the county. With the help of many supporters, funding has been provided to dozens of organizations for the express purpose of advancing the health and well-being of all Greene County residents.



## **EQT REC Center Opens for Business**

On November 7, 2017, the Greene County Memorial Hospital Foundation opened the brand new EQT REC Center on EverGreene Drive in Waynesburg. Built with community focus in mind and not simply athletics, the center houses community rooms, party rooms a conference room, a babysitting room, a fully equipped game room, basketball courts, a large fitness area, indoor soccer field and a walking track overlooking the soccer field.

In just two months, membership grew to more than 2,000 members and groups and individuals were quick to rent out the various rooms for a variety of activities as well. In addition to fitness memberships, the EQT REC Center also offers leagues and sports instruction.

Donations are still being accepted to contribute to this bold initiative and recognition is available in a variety of ways, from the engraved bricks at the front entrance to the donor wall in the lobby.

# Greene County Memorial Hospital Foundation awards \$10,000 in scholarships to five area graduates.

In May, the Greene County Memorial Hospital Foundation (GCMHF) once again awarded five scholarships to graduating seniors, one from each of the local school districts. The winners each received \$2,000 and intend to pursue a career in healthcare.

This is the tenth consecutive year GCMHF has awarded healthcare scholarships to graduating seniors from Greene County. Combined with various nursing and medical student tuition assistance programs, GCMHF has awarded more than \$300,000 over the past ten years to Greene County students pursuing secondary healthcare degrees.

## Corner Cupboard Food Bank Receives Assistance

Corner Cupboard was founded in October 1992, to address the needs of the hungry population in Greene County. Its humble beginnings started out in the basement of the County Office Building with a dedicated hand-



ful of volunteers who hand loaded every order.

As it became clear Greene County residents would not turn away from their neighbors in need, they quickly outgrew their location. Thanks in part to the donation of land by the County Commissioners and a capitol campaign which raised more than \$300,000 a new facility was built at 881 Rolling Meadows Road, Waynesburg.

Today, more than 20 years later, Corner Cupboard has increased capacity to feed well over 2,000 people every month, through a network of 11 pantries throughout the county. With the dedication of 2 full-time staff members, 11 Pantry Coordinators, 8 Board Members, and more than 150 Volunteers, Corner Cupboard is truly a community effort of "Neighbors Helping Neighbors".

A year ago the Greene County Memorial Hospital Foundation completed its \$100,000 five-year commitment to the Food Bank. The Foundation stepped up once again to assist the food bank with a grant of \$10,000 this year. Executive Director of the Food Bank, Candace Tustin,

was thrilled to receive the great news and grateful for the continued support of the Hospital Foundation. For every \$1 that is donated to the food bank, they can purchase \$5 worth of food. Ms. Tustin stated that monetary

donations and contributions like that of GCMHF are essential to continuing the mission of the food bank.

Secondly, in a joint effort with the Community Foundation of Greene County, the Foundation contributed \$8,000 for a weekend food program for 2017/2018 school year. The Weekend Food Program began with two schools and thirty-six children back in April, 2012. It now provides bags of food to more than 150 elementary age school children throughout the five schools districts within the county. These children have been identified by school personnel as high risk food insecure and typically show signs/symptoms of coming to school hungry.

By partnering with the Community Foundation at the beginning of the school year, the schools were able to get the program started earlier and be confident of the number of children they can serve throughout the year. In the past, many of the schools had to wait and were unsure as to the numbers they could serve due to limited funds.

# GCMH Foundation Awards Catholic Charities \$5,000 for Rollercoasters Program

"I didn't cause it. I can't fix it, but I can cope." Ask any student who has completed the Rollercoasters program in Greene County and they will tell you that they can cope with family changes. The program is provided for the schools in Greene County who wish to participate. Through interactive games, stories and activities the students who participate will learn coping skills that are valuable to all individuals but particularly to those who are dealing with family change.

Over the past 6 years GCMHF has provided nearly \$90,000 in funding for this very vital program. Eleven separate groups of 223 children for grades one through five participated in the 8 week program of 2016- 2017 consisting of the following themes:

- Understanding healthy ways to adjust to changes in family dynamics
- ♦ Dealing with divorce and other life changes and realizing they are not the child's fault
- Grieving helps us move forward, making room for new experiences and growth
- ♦ Organizing feelings around events and experiences to improve self-esteem
- Discovering healthy coping skills to deal with anger and sadness
- ♦ Problem solving skills

- ♦ Preparing for new changes
- ♦ Synthesizing what has been learned

More than 46% of the students who participated in the programs were from a split family home and more than half of these children reported thinking about their families problems often. Measurable results indicated 90% of the children had reportable improvements in their behavior with more than 99% improving their coping skills from the first to final session. Additionally, four students were referred to their guidance counselor for further support

In many instances teachers were able to notice dramatic results. They reported the program helps them better understand and help their students and commented many more students were able to talk about their feelings.

#### Teachers wrote:

- ♦ "The student is emotionally calmer and is able to focus more in class... thank you."
- "This program is engaging and age-appropriate. I recommend it to everyone. Mrs. Lorie is a wonderful asset to the program."
- ♦ "The sessions are wonderful."
- ♦ "The student had a lot of issues... without this program it would have been a lot worse for her."

# Greene County Career and Technology Center Receives Grant to Aid Nursing Students

For the sixth consecutive year, GCMHF approved a grant to Greene County Career and Technology Center. Each year the foundation provides funding to the center in order to purchase mandatory equipment for each nursing student. The equipment comes in a duffel bag the student gets to keep upon graduation and contains much of what they need to master prior to taking their nursing board exams.

Judy Swauger, Coordinator of Practical Nursing Program, knows this gives her students an advantage by utilizing their own medical equipment, kits and supplies. "Nurses are the backbone of the healthcare system. The Greene County Career & Technology Center has been educating nurses in Greene County since 1970. They learn, practice and demonstrate proficiency in nursing skills prior to clinical rotations at our various facilities. They then utilize those skills throughout their career."

The practical nursing program partners with various civic organizations to assist in promoting health and wellness within the community. A few examples are:

- Cornerstone Care's Smile for Life Program
- Community Action's Head Start
- Rainbow's Fnd
- Blood pressure screenings at local sites
- American Cancer Society's Relay for Life

Along with completing all coursework, students must work more than 1,600 hours in order to graduate.



# Central Greene School District Receives Two Grants

For the sixth consecutive year the Greene County Memorial Hospital Foundation has awarded a grant to Central Greene School District to help defray the cost of operating their swimming pool. As the only viable lap pool in Greene County, the Foundation feels it is important for the community to have a facility such as this.

In addition to the grant for the swimming pool, the Foundation also provided a grant in the amount of \$1,800 for ALICE Training (Alert, Lockdown, Inform,



Counter, Evacuate). ALICE Training attempts to keep children safe from all threats including human-caused emergencies such as crimes of violence. This focus coincides with the schools

CERTIFIED district's mission which is to provide a comprehensive education for all students to become successful critical thinkers as they enter a global society.

It is an online program that is available to all staff, faculty, administration and substitutes. The training in turn will then be provided to the students through drill practices during the school day. The total number of people this will impact is more than 2,000.



#### **GCMHF Purchases More AED's**

GCMH Foundation was pleased to once again contribute to several local nonprofit groups for the purpose of purchasing Automated External Defibrillators. These devices are capable of saving a life and can be operated by people with no medical background.

Receiving an AED this year were the Carmichaels and Cumberland Volunteer Fire Department, the Jefferson Morgan School District and the First Assembly of God. The Foundation has purchased more than twenty AED's over the past few years and is pleased to be able to provide this life saving device throughout Greene County.


